4. BLUE ZONES OCTOBER 2020 UPDATE

The Committee received information about Blue Zones current programs and offerings.

Tracy Burke Vasquez, Go831 Program Coordinator, introduced Kendra Howell, Senior Policy Lead of Blue Zones Monterey County. Ms. Howell presented information about Blue Zones' joint effort with the Transportation Agency's Go831 program to promote the October Smart Commute Challenge. She noted that the Transportation Agency's Go831 program encourages activities that reduce congestion in Monterey County.

The Blue Zones Project is a community-by-community well-being improvement initiative designed to help people live longer, better lives by making healthy choices easier. The initiative promotes simple permanent or semi-permanent changes to community, organization and home environments that support healthy lifestyle behaviors and habits based on cultures identified around the world that have high percentages of centenarians, labeled Blue Zones by the National Geographic. In conclusion Ms. Howell noted that the current Blue Zones Monterey County efforts including creating a community safety education campaign that supports promoting walking and bicycling more, and Salinas' Vision Zero effort to eliminate traffic related fatalities. She noted that it has been hard for a lot of businesses during COVID-19. She mentioned that the City of Salinas Council approved a Vision Zero Policy. The Vision Zero Policy is a strategy to eliminate all traffic fatalities and severe injuries collision, while increasing safe, healthy equitable mobility for all ages. The City has also been working on the soccer project and a community garden at Creek Park.

Committee member Ralph Wege asked if Blue Zones is organizing a clean-up on the bike path on Castroville. Kendra Howell replied that no bike path clean-up is currently planned, but possibly in the future.

Committee member Mike LeBarre noted that having on a Blue Zones cooking show in both English and Spanish would be helpful. Kendra Howell replied that fun and healthy recipes would help people engage in healthy eating, and Blue Zones recently recorded a Spanish-language cooking show that will be released soon.

Committee member Libby Sofer noted that the City of Sand City completed the virtual mural project. She encouraged the committee members and community to check it out via walking on biking, social distancing is encouraged.

Kendra Howell, mentioned that the downtown Salinas is working on a remodeling near La Fogata. She mentioned some planters were removed, they will be installing lighting and chairs and possibly artwork.

Committee member, Eric Petersen, asked how to find out what business are Blue Zones approved or how to help businesses that are interested. Kenda Howell replied that Blue Zones are developing little cards that will help explain the process that can be distributed.

Eric Petersen announced that at the Litter Valley Summit Rick was given an award for picking up litter. He also noted that on N. Boronda Road, the City of Salinas has a project that is not following the Highway Design Manual. He asked to have the Central project on a future meeting date.

Tracy Burke, Go831 Program Coordinator noted that she went to the City of Sand City and walked around to see the murals. She highly encouraged everyone to view.

Chairman Jack Smith expressed concern on the no signal on Molera Road. He noted that it is dangerous for long distance bike travelers who are not from the area. He encouraged for staff to work on installing a wayfinding sign on that area. He also thanked everyone for the two years. He mentioned that it is really important to get someone to represent North county especially the Pajaro and Las Lomas community.

Committee member Hans Hoffmann noted that we encourage future projects with bulb-outs to consider the impact to bicyclists. The pedestrians and cyclist are being squeezed next to cars. We should modify the depth and make sure bicycle can fit through.

Madilyn Jacobsen, Transportation Planner, announced that Transportation Agency has launched a new website available at tamcmonterey.org.

Subject: 2021 Legislative Program

RECOMMENDED ACTION:

RECEIVE and **COMMENT** on draft 2021 Legislative Program.

SUMMARY:

The purpose of the legislative program is to set general principles to guide staff and Board responses to legislative or budgetary proposals. The program also notifies state representatives of the Transportation Agency's position on issues of key importance to the Agency.

FINANCIAL IMPACT:

The recommended action has no direct financial impact.

DISCUSSION:

The draft 2021 legislative program continues to focus on transportation funding and is limited to priorities that are likely to come up in the 2021 legislative session. **Attachment 1** is the draft legislative program.

Items of particular interest to this Committee include:

State:

- 1S. Preserve funding for transportation projects, maximize formula funding to regions, and preserve regional discretion and priority-setting.
- 2S. Pursue competitive grant or bond funding for highway safety, traffic congestion relief, trade corridors, passenger rail, and public transportation for Monterey County projects.
- 3S. Promote jobs-housing balance and alternative transportation modes as ways to reduce vehicles miles traveled, while maintaining statewide equity between urban and rural areas.
- 9S. Support legislation to increase safety and reduce fatalities by modifying laws establishing speed limits to be based on safety considerations, with attention to enforcement of speed limits.
- 10S. Support legislation to devote more funding to the oversubscribed Active Transportation Program.
- 14S. Support legislation that promotes transit-oriented development (such as via redevelopment or opportunity zones), complete streets, alternative commutes, multi-modal transportation, and active transportation projects.

Federal:

• 1F. Support stabilizing and increasing transportation infrastructure funding sources to avoid the bankruptcy of the federal highway and transit trust funds in the multimodal transportation authorization bill.

In October, the Executive Committee discussed this draft legislative program and the Board approved releasing it to Committees for input. The Rail Policy Committee and the Technical Advisory Committee will review the draft in November. Staff will also meet with partner agencies locally and statewide to discuss common issues. Following the Executive Committee's review of the draft program in January, the final program will come back to the Board in January for adoption.

- **15.** Preserve funding for transportation projects, maximize formula funding to regions, and preserve regional discretion and priority-setting.
- **25.** Pursue competitive grant or bond funding for highway safety, traffic congestion relief, trade corridors, passenger rail, and public transportation for Monterey County projects.
- **35.** Promote jobs-housing balance and alternative transportation modes as ways to reduce vehicles miles traveled, while maintaining statewide equity between urban and rural areas.
- **45.** Support funding for electric vehicle charging infrastructure and rebates for electric vehicle purchase.
- **5S.** Explore replacement funding mechanisms for transportation investments, such as a pay-by-the-mile user fee, public private partnerships, or wholesale energy taxes.

DRAFT 2021 Legislative Program Federal Priorities

- **1F.** Support stabilizing and increasing transportation infrastructure funding sources to avoid the bankruptcy of the federal highway and transit trust funds in the multimodal transportation authorization bill:
 - 1. Increase and index the gas tax to inflation.
 - 2. Explore innovative funding mechanisms, such as a pay-by-the-mile user fee, public private partnerships, or wholesale energy taxes.
 - 3. Expand access to Transportation Infrastructure Finance and Innovation Act (TIFIA) loans.
 - 4. Remove procedural obstacles that impede expenditure of authorized federal funding, including cash flow options for small and rural grantees.
 - 5. Support the return of directed federal funding for transportation priorities.
 - 6. Coordinate with military installations in Monterey County to seek funding for transportation projects with a nexus to those installations.
 - 7. Support Monterey-Salinas Transit application for federal funding for the SURF Bus Line in the Monterey Branch Line corridor.
 - 8. Support applications for the Better Utilizing Investments to Leverage Development (BUILD) Transportation Discretionary Grant program on the California Central Coast.
- **2F.** Allow the California Environmental Quality Act (CEQA) to substitute for the National Environmental Policy Act (NEPA), and expand the definition of Categorical Exclusions, while retaining environmental protections.
- **3F.** Advocate for the Federal Communications Commission to regulate broadband/internet access as a utility to enable the increase of broadband infrastructure capacity to help bridge the digital divide and to encourage telecommuting.

- **4F.** Support streamlining of federal rail funding and removal of funding barriers between commuter and intercity rail programs, with the goal of increasing passenger rail service for the traveling public.
- **5F.** Support an adequate level of funding for Amtrak to restore pre-COVID-19 service level and support a fair share allocation to California for capital improvements and vehicle acquisition.
- **6F.** Support member agencies' requests for federal funding of regionally significant transportation projects and support partner agency legislative efforts as they interface with regional transportation priorities, when they are consistent with Transportation Agency for Monterey County priorities.
