


The Main Problem

Phase II: Close Portola Entrance from Hwy 68





Smooth Sailing at School Drop-Off








Phase II Partial Road Closure Portola Drive/Creekside Ct.



October 8 Workshop

- •89% of all respondents think we successfully eliminated cut-through traffic
- •Over 1/3 of respondents feel the pilot project is a hardship and caused distress
- •Almost 1/2 of respondents drive towards Monterey each morning and this was a main complaint received (commute got worse)
- •46% respondents love/like the pilot project
- •37% of all respondents hate the pilot project
- •69% say we're heading in the right direction but not there yet (e.g., improve Highway 68)



Alternatives Under Consideration

- 1. Do Nothing: remove everything and go back to the way it was
- 2. Keep Pilot: keep partial road closures where they are and upgrade them
- 3. Relocate Closures: select locations that better serve the community
- Bus Gates: Use gates to active (close road) when Highway
 68 is congested
- 5. Relocate merge: move merge upstream so that traffic flows smoothly along Toro Park and no one needs to cut through anymore

Comments received: Support

- ... I really appreciate how this pilot project has restored the peace in our community!!!
- >...I am in total agreement about the closing of Portola to westbound traffic... I've seen people making a 2nd lane by driving partly on the dirt and then I saw cars forming a separate 3rd lane to turn left to head east on 68. Yes...they were on the wrong side of the double yellow stripes and blocking the lane to oncoming traffic.
- The single Torero Dr. inlet / Portola Dr. outlet has been the best solution for Serra Village at this point in time, forcing commuters to stay on Highway 68...The project has most definitely improved the quality of life in our community... my wife shared [that] it's truly quieter (can actually sleep in now), it's safer (fewer cars + speeders), it's easier to back out of our driveway, and gathering curbside for an impromptu chat with a neighbor no longer involves keeping a constant, wary eye on cars, or yelling as often to tell speeding drivers to slow down.
- Regardless of these behaviors (I have photos) we fully support this, and hope that this and the Torero limitations become permanent.
- ➤I do appreciate that TAMC has installed these measures to stop cut through traffic on Portola Drive. This has made traffic less congested on Portola Drive for drivers going to Toro Park School!

Comments received: Opposed

- >We're apparently now in the aggression phase of this transition...
- The outcome of the changes for me: I have to get up earlier... so I can merge onto 68 before things get really backed up. Less sleep, more stress.
- ...ongoing petition opposed to closing Torero Dr. As of this morning there are 204 signatures... Closing Torero Drive has created a hardship for many residents who live on the west side of Toro Park... The wasted time, fuel, vehicle wear and tear, and pollution is unacceptable. The closure has not significantly improved traffic flow on highway 68 and driver's are still looking for a way around the traffic. Any solution to the Portola traffic problem should keep Torero open in both directions as it has been for the last +45 years... immediately open Torero and continue to explore a solution that does not marginalize a large portion of the Toro Park community.
- Aggressive drivers are everywhere... Toro elementary is a Kindergarten to 3rd grade school, meaning that not many of these students walk to school. Portola is congested with traffic only for a few hours from my observation. Usually Monday Friday from 6:30am to 8:30am that's 2 hours a day... I read that "some residents could not even exit their driveways" that's an exaggeration.
- It was stop and go traffic all the way to the place where the two lanes merge into one lane. It took about 22 minutes.
- The west end of Toro Park needs an exit that isn't a mile away.

How Traffic Decays Quality of Life

- Feel land-locked
- ❖45-minutes to drop off students (stress)
- Side street traffic (roads weren't built for this)
- ❖ Need to reschedule because can't get out of driveway for 20 minutes
- *Aggressive drivers and hostility and exhaust make for uneasy walks in the mornings
- Commercial trucks that don't have business in neighborhood
- Emergency response times
- Home values down from congestion
- Don't need a clock to know when school starts
- **❖** We need to take back our neighborhood!
