History of County Code Ordinance Update for E-bike Use

December 2021 – County of Monterey Parks Commission received an informational report on Ebike history and use

December 2022 – Parks Commission forms Ad Hoc Committee to research E-bike use and report back to the Commission on moving forward with an ordinance update

July–September 2023 – County-wide E-bike survey takes place; direct email, posted in parks and ad taken out in Monterey Weekly, King City Rustler and Carmel Pine Cone


June 2024 – Draft ordinance presented to Parks Commission which was split on various aspects of the draft ordinance

October 2024 – Revised draft ordinance presented to Parks Commission and was accepted to be carried forward to the County of Monterey Board of Supervisors for approval



E-bike Survey

- Online survey was conducted for 3 months in English and Spanish; approx. 1,300 respondents
- Direct email, newspapers, social media and County website
- Approx. 63% in favor of allowing E-bikes on County Parks multi-use trails

Draft Ordinance for Monterey County Code 14.12 Update

Define Class 1, 2 and 3 E-bikes

Class 1 – pedal assist up to 20 mph Class 2 – pedal assist or throttle up to 20 mph Class 3 – pedal assist up to 28 mph

Allow Class 1, 2 and 3 E-bikes on County Parks dirt trails

No electric motorcycles, mopeds, scooters or other modalities

Safe passage guidelines

All passing must occur at 5 mph or less

All trail users give way to equestrians, bikers give way to pedestrians
