4. RAIL POLICY COMMITTEE ELECTIONS

The Committee held elections for Vice Chair for 2025-26.

M/S/C Smith / Mora /unanimous

Committee Member Smith nominated Committee Member Carbone as Vice Chair and the motion was seconded by Committee Alternate Mora.

Chair LeBarre reported that the Committee needs to select a Vice Chair from its membership to complete outgoing Vice Chair Potter's two-year term. To be eligible to serve as the Chair or Vice Chair, the person must be a voting Agency Board Member and have served on the Rail Policy Committee for at least one year.

5. <u>COAST CORRIDOER RAIL PROJECT UPDATE</u>

M/S/C Smith / Carbone /unanimous

Committee Member Smith nominated Dave Potter as the TAMC representative to the CRCC Policy Committee and Chair LeBarre as his alternate, and the motion was seconded by Vice Chair Carbone.

The Committee received an update on the planned increase in passenger rail service along the coast corridor between San Francisco and Los Angeles; and recommended the Board of Directors appoint representatives to the Coast Rail Coordinating Council Policy Committee.

Christina Watson, Director of Planning, reported that the project was awarded \$63 million to improve the rail between Monterey and Santa Barbara Counties. She also noted that appointments to the CRCC Policy Committee for the period ending January 2026 involves attending up to four meetings of the CRCC Policy Committee and potentially representing the group at a legislative day in Sacramento and the California Passenger Rail Summit.

Ms. Watson noted that the next CRCC Policy Committee meeting is planned for February 21 in Santa Barbara.

6. PAJARO MULTIMODAL STATION PROJECT UPDATE

The Committee received an update on the Pajaro Multimodal Station Project.

Alissa Guther, Transportation Planner, reported that the Pajaro Multimodal Station project held a Scoping Workshop that over 80 residents attended, as well as meetings with Union Pacific Railroad Company and stakeholders on the design options, and with Caltrans staff to discuss the federal Corridor ID funding program. Ms. Guther noted that they have held Pajaro residents group meetings and Corridor ID coordination kick-off meeting with Federal Railroad Administration staff.

Committee Member Smith expressed concerns about floodplain mitigation options. Ms. Guther replied that the area flooded in 2023, and she is setting up a meeting with the Army Corps to discuss levee repair work. She noted that a mitigation report will be included in the Environmental Impact Report. Committee members requested a report back on current projects at or near the Pajaro River.

7. SALINAS RAIL KICK START PROJECT UPDATE

The Committee received an update on the Salinas Rail Kick Start Project.

Christina Watson, Director of Planning, reported that the activities on the Salinas Rail Kick Start project since the last update include operations scenario discussions, design coordination efforts with key stakeholders on Package 2 and 3, and right-of-way appraisals for Union Pacific Railroad-owned property. Ms. Watson noted that the project will not meet the State Transportation Improvement Program (STIP) funding deadlines. She said that when the team has a revised construction cost estimate, staff will bring a new funding proposal to the Committee and the Board for feedback and approval.

Committee Member Smith noted to consider a Board workshop or study session to go over the more technical processes and considerations for funding the project for the new board members.

Chair LeBarre asked for the item to be brought back to lay out clear recommendations to keep the project funded. Executive Director Todd Muck replied that once we have an update on estimates and easements, we will bring the item to the Rail Policy Committee and Agency Board to approve.

Mike Zeller, TAMC Director of Programming & Project Delivery, reported on the right-of-way phase of work, noting staff has been working with Union Pacific Railroad (UPRR) on the plans, and trying to meet Caltrans right-of-way funding certification deadline. He noted the team continues to work on appraising parcels that TAMC may need to acquire access to from UPRR.

SUMMARY:

Progress since the last update on the coast rail project to this Committee includes a meeting of the Coast Rail Coordinating Council working group.

FINANCIAL IMPACT:

The Coast Rail project capital and operation costs are under evaluation.

DISCUSSION:

The Coast Rail Coordinating Council (CRCC) is a multi-agency advisory and planning organization focused on improving the rail corridor between Los Angeles and the San Francisco Bay Area along the California Central Coast. Members of the Council include all Regional Transportation Planning Agencies along the Central Coast – all of which have a strong interest in improving rail service and the rail infrastructure along the Central Coast's portion of the California Coast Passenger Rail Corridor.

The CRCC working group met virtually on January 17, 2025 and discussed the following:

- Senate Bill 125 fund allocations:
- Transit & Intercity Capital Program grant award next steps;
- Positive Train Control project; and
- Federal Corridor Identification and Development program.

Subject: California State Rail Plan & Corridor ID Updates

RECOMMENDED ACTION:

RECEIVE presentation on the 2024 State Rail Plan and update on the Federal Railroad Administration Corridor Identification and Development (Corridor ID) process.

SUMMARY:

Caltrans Division of Rail will present an update on the 2024 State Rail Plan and the Corridor ID process.

FINANCIAL IMPACT:

The Rail Plan outlines a vision for rail implementation that indicates state-level support for increased passenger rail service to Monterey County that will help the Agency secure future grant funds. The Federal Railroad Administration Corridor Identification and Development (Corridor ID) process will directly support the advancement of Monterey County rail projects and enable them to secure federal grants.

DISCUSSION:

To meet California's environmental, economic, and equity goals, the State must continue to build towards a fully integrated, zero-emission rail and transit network. The California State Rail Plan provides solutions for congested corridors across California and identifies how the State will prioritize investments that provide Californians with more frequent, reliable rail service to more destinations, with travel times that are competitive with traveling by air and auto. Attached online as **web attachments** are the 2024 State Rail Plan, a fact sheet, and appendices.

The Rail Plan outlines a long-term vision to guide incremental service planning to support development of a statewide network, a 10-year service and capital plan representing phased goals for advancing the network design, and a 5-year capital program supporting near-term funding and programming needs. The service and connectivity goals along with corridor-level improvements required to deliver the Rail Plan are described in the capital program, which is split into three phases: capital projects identified for the next four years (2028); mid-range needs identified for the next decade (2034); and plans for long-range improvements and investments by 2050. Regional implementation planning and project delivery build on the Rail Plan, as communities realize improved service, develop regional networks, and set land use recommendations that leverage enhanced connectivity.

Integrated scheduling concepts are a component of the network integration initiatives described in the Rail Plan, which include development and implementation of the California Integrated Travel Program

(Cal-ITP) for integrated ticketing and modern fare collection supported by the State, as well as development of a statewide rail and bus equipment procurement program at Caltrans to strategically standardize long term equipment procurement around zero-emission technologies.

Near-term (2028) service goals for the Monterey Bay Area include service expansion from San Jose to Salinas to provide three round trips and enhanced connectivity to the Central Coast.

Midterm (2034) service goals include the doubling of service frequency between San Jose to Salinas.

Long-term (2050) service goals include extending all-day intercity service between San Jose and San Luis Obispo via Salinas with connections to a regional rail network connecting Santa Cruz and Monterey.

Chapter 4.5, Planning for Future Investments, cites the following under the header "Near-Term Vulnerabilities and Areas of Concern":

Elkhorn Slough is a large tidal salt marsh located on the central coast of California, near Monterey Bay, and serves as an important habitat for diverse wildlife, including birds, fish, and marine mammals. An 8-mile stretch of Highway 1 and nearby rail represents a critical commuting and freight expansion corridor in the area that is at risk due to rising sea levels. The Transportation Agency for Monterey County (TAMC), in partnership with Caltrans, is conducting the Highway 1 Elkhorn Slough Climate Resiliency Project, which addresses the vulnerability of the transportation infrastructure through the Elkhorn Slough, focusing on multimodal and nature-based solutions to climate change impacts. The initiative is backed by Caltrans' funding for preparing a Planning and Environmental Linkages (PEL) study and project documentation.

The Federal Corridor Identification and Development (Corridor ID) program includes \$500,000 for Caltrans to work with the Federal Railroad Administration (FRA) and local sponsor agencies to prepare a Scope of Work for a Service Development Plan (SDP) for the Central Coast corridor. The SDP will outline details like train schedules, station locations, and potential economic impacts. The exact budget for the SDP is still being determined as part of the scoping process, but it is expected to be fully funded by Caltrans and the FRA through the Corridor ID program.

Subject: Salinas Rail Kick Start Project Update

RECOMMENDED ACTION:

RECEIVE update on the Salinas Rail Kick Start project.

SUMMARY:

Activities on the Salinas Rail Kick Start project since the last update include operations scenario discussions, design coordination efforts with key stakeholders on Packages 2 (Salinas layover facility) and 3 (Gilroy track connections), and right-of-way negotiations with Union Pacific Railroad.

FINANCIAL IMPACT:

The capital cost of the Monterey County Rail Extension project, Phase 1, Salinas Kick Start project (the Salinas station and improvements in Santa Clara County), is estimated to total \$87 million for all phases of work. The Kick Start project is proceeding with secured state funding under the adopted state environmental clearance and is currently in the final design phase.

DISCUSSION:

The Monterey County Rail Extension Project will extend passenger rail service from Santa Clara County south to Salinas. TAMC is pursuing a phased implementation of the Project. Phase 1, known as the Kick Start Project, includes Salinas train station circulation improvements, a train layover facility in Salinas, and track improvements at the Gilroy station and between Salinas and Gilroy. The Kick Start Project has wrapped up construction of Package 1, improvements at the Salinas train station. The layover facility (Package 2) and Gilroy track improvements (Package 3) are now in final design.

Final Design

HDR Engineering prepared the 100% plans, specifications and estimates for stakeholder review on September 1, 2022, and has gathered stakeholder input on those plans. Since the last report to this Committee, the design team has continued to coordinate design review with Union Pacific Railroad (UPRR) and the City of Salinas.

Property Acquisition

Four parcels remain that are potentially required for the layover facility and Gilroy track improvements, which are owned by Union Pacific. Property rights negotiations have been on hold pending Union Pacific's review of the design plans. TAMC staff requested permission to begin discussions with the Union Pacific real estate division and are coordinating this effort with the Agency's right-of-way consultants of Bender Rosenthal and Nossaman.

Staff will give a verbal update at the meeting.

Activities on the Pajaro Multimodal Station project include the meetings with Union Pacific Railroad Company, coordination with Santa Cruz County Regional Transportation Commission staff, and Caltrans and Federal Railroad Administration coordination to discuss the Corridor Identification and Development (Corridor ID) funding program.

FINANCIAL IMPACT:

Pre-construction work began in 2024 with state-secured funding for environmental review. In April 2023, the California State Transportation Agency (CalSTA) approved a \$2.3 million grant to cover the cost of California Environmental Quality Act and National Environmental Policy Act documentation. This documentation will allow TAMC to pursue further state and federal funding for the design update and right of way work. The total estimated cost of pre-construction work for the Pajaro Multimodal Station Project, which includes environmental review, design, and right of way, is \$19.5 million.

DISCUSSION:

The Monterey County Rail Extension Project will extend passenger rail service from Santa Clara County south to Salinas. TAMC is pursuing a phased implementation of the Project. Phase 2 is the Pajaro/Watsonville Multimodal Transit Hub. The proposed Pajaro/Watsonville station will be the connection point for Santa Cruz County to new passenger rail service on the Coast mainline tracks between Salinas and the San Francisco Bay Area, as well as a hub for future round-the-bay service.

After a successful application to the Transit and Intercity Rail Capital Program (TIRCP), TAMC received \$2.24 million to fund environmental review documentation, which is currently underway.
